The Board of Directors of the Company have passed a resolution on 12th August, 2015 and decided to provide to the shareholders of the Company, a facility to exercise their votes on the resolution(s) as set out in the notice of the 26th Annual General Meeting dated 12.08.2015 by way of remote e-voting and voting through ballot papers at the AGM as required under the provisions of Section 108 of Companies Act, 2013 read with Companies (Management and Administration) Amendment Rules, 2015 and the Listing Agreement.

I, Ashu Gupta, Company Secretary in Practice of M/S Ashu Gupta & Co. has been appointed by the Board of Directors of the company as the scrutinizer pursuant to the provision of Section 108 of Companies Act, 2013 read with Companies (Management and Administration) Amendment Rules, 2015 and the Listing Agreement for the purpose of scrutinizing the aforesaid remote e-voting process and voting through ballot process in a fair and transparent manner and ascertaining the requisite majority for passing of resolutions as contained in the notice dated 12.08.2015 convening the 26th Annual General Meeting of the Company held on 30th September, 2015 at Hotel Fortunne, Opposite Avas Vikas Gate, Bareilly Road Kichha, Distt. Udham Singh Nagar, Uttarakhand-263148.

The compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder relating to voting through electronic means (remote e-voting) and voting by using ballots by the shareholders on the resolutions proposed in the notice of the 26th Annual General Meeting of the Company is the responsibility of the management. My responsibility as a scrutinizer is to ensure that the voting process both through electronic means and by use of ballot at the meeting are conducted in a fair and transparent manner and render consolidated scrutinizer's report of the total votes cast in favour or against if any, to the Chairman of the



meeting on the resolutions, based on the reports generated from the electronic voting system, provided by the CDSL and the report generated electronically for voting by use of ballots at the meeting.

The notice dated 12th August, 2015 convening the 26th Annual General Meeting of the Company held on 30th September, 2015 along with the statement setting out material facts were sent to the shareholders of the Company.

The shareholders of the Company holding shares on the "cut-off date" i.e. 23rd September, 2015 were entitled to vote on the resolutions proposed as set out in the notice of the 26th Annual General Meeting by remote e-voting or voting through ballot papers at the 26th AGM.

In this regard, I submit my consolidated report as under:

- The remote e-voting period remained open from 27th September, 2015 (10:00 AM) to 29th September, 2015 (5:00 PM) and was disabled for voting thereafter.
- The members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of 23.09.2015, were entitled to vote electronically on agenda items by remote e-voting or voting through ballot paper at the 26th AGM.
- After the declaration of Poll by the Chairman, 1 (one) Ballot box kept for the ballot paper for the purpose of voting through ballots, was locked in our presence with due identification marks placed by us.
- 4. The locked ballot box was subsequently opened in our presence and ballot papers were diligently scrutinized. The ballot papers were reconciled with the records maintained by the Company/ Registrar and Transfer Agents of the Company.
- The ballot papers which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- 6. After counting the votes cast by the members and proxy holders present at the 26th Annual General Meeting through ballot paper, the votes cast through remote e-voting were unblocked on 30th September, 2015 around 1:20 PM in the presence of two witnesses, Ms. Yanika Verma D/o Shri. D.S. Verma and Ms. Surbhi Maheshwari D/o Shri S.D. Maheshwari, who are not in the employment of the Company and who have signed below as confirmation to unblocking of the votes.
